## Important Notes

- 1) *If you are already giving to the Cruden Trust please don't simply increase your donations without completing this form.* We need to know that money is being given specifically to this purpose. Also, even if you are already giving with Gift Aid please complete that section of the form as well.
- 2) Likewise, if you are already giving monthly to the Building Fund, please complete this form to indicate how you will give from this point onward. This pledge form replaces any previous commitment to the building fund.
- 3) Your completed form will be dealt with in the strictest confidence and in the same way as all donations to the church and the Cruden Trust.
- 4) If you are a tax payer, Gift Aid allows the Cruden Trust to reclaim income tax payable on gifts received. You must pay an amount of income tax and/or capital gains tax at least equal to the tax the Trust reclaims on your donations in the tax year (currently 25p for each £1 you give).
- 5) If you are a higher rate tax payer, you can claim further tax relief in your Self-Assessment return. Note that the tax payer receives back this benefit not the Trust.
- 6) In the case of husband and wife making a joint donation and wishing to claim Gift Aid, please ensure that the pledge form and gift aid declaration are signed by a spouse who qualifies for Gift Aid.
- 7) You can cancel, decrease, or increase your pledge at any time by writing to The Treasurer, The Cruden Trust, 63 Wingate Road, Aberdeen, AB24 2SZ.
